### Call to Order

Bertha Byrd said that we need to send a letter right now demanding that faculty be included on the faculty selection committee for new faculty. Henry Cole said that there is a need for a faculty senate, and that he would like to propose an ad hoc committee to look into forming a faculty senate.
